

State of Illinois Directory of Compliant NPMs as of February 1, 2008

Distributors:

Sales of cigarettes manufactured by NPMs on this list must be reported on the quarterly reporting form. Sale of cigarettes manufactured by noncompliant NPMs is prohibited.

In order to be lawfully sold in the State of Illinois, both the non-participating manufacturer and the brand family must appear together on this list.

Effective January 1, 2008, the Cigarette Fire Safety Standard Act (425 ILCS 8/1 et seq.) provides that no cigarettes shall be sold or offered for sale to any person in Illinois unless they are certified and approved as in compliance with the Act. The Act permits that inventory of cigarettes existing on the effective date of the Act may be sold in compliance with Section 10(b) of the Act. The Office of the State Fire Marshal and the Office of the Attorney General will cooperate to produce a list of cigarette brands and styles that are legal for sale in Illinois. Until such a list is published, cigarettes listed on this Directory may be sold so long as they are made to meet fire safety standards or qualify under the inventory sell-off provision.

The Office of the Attorney General may periodically update this directory by either adding or removing brand families and/or non-participating manufacturers. Please contact the Office of the Attorney General at 217-785-8541 with any questions regarding this directory.
